# Driving Directions to: Noviello Financial Group Headquarters, Bridgewater, NJ

### From Northern NJ via I-287 Southbound

Take Route I-287 South to Exit 17, to Route 202/206 South - Somerville Flemington (go 1.0 miles)

Take Ramp (Right) to Route 22 West - Clinton (go approx. 1.6 miles)

Note: You will pass Ethicon (Somerset Corporate Center) and MetLife on your right.

Take U-Turn @ traffic light immediately after MetLife to proceed East on US 22 East.

Immediately through the traffic light you will pass Cordis, Alpharma & St Bernard Roman Catholic Church. The next driveway after St Bernard's Church is the Federal Credit Union (purple & white sign) and the 520 Entrance, turn right into driveway.

Enter the lobby from either side of the building and proceed to the 3rd Floor and follow signs to NFG.

#### From Southern NJ via Route 202 Northbound

Take Route 202 North to exit for Route 22 West - Clinton Proceed 1.8 miles on Route 22 West.

Note: You will pass Ethicon (Somerset Corporate Center) and MetLife on your right.

Take U-Turn @ traffic light immediately after MetLife in order to proceed East on Route 22.

Immediately through the traffic light you will pass Cordis, Alpharma &

Take Route 287 North to Exit 14B (Left Exit) to Route 22 West - Clinton.

Proceed on Route 22 West - Clinton for approximately 3.9 miles.

Note: You will pass Ethicon (Somerset Corporate Center) and MetLife on your right.

Take U-Turn @ traffic light immediately after MetLife in order to proceed East on US 22.

Immediately through the traffic light you will pass Cordis, Alpharma & St Bernard Roman Catholic Church. The next driveway after St Bernard's Church is the Federal Credit Union (purple & white sign) and the 520 Entrance, turn right into driveway.

Enter the lobby from either side of the building and proceed to the 3rd Floor and follow signs to NFG.

#### From Southern NJ via Route 206 North

Take Route 206 North (from Princeton area) to the Somerville Circle (202/206 Circle).

Take U-Turn @ traffic light immediately after MetLife in order to proceed East on Route 22.

Immediately through the traffic light you will pass Cordis, Alpharma & St Bernard Roman Catholic Church. The next driveway after St Bernard's Church is the Federal Credit Union (purple & white sign) and the 520 Entrance, turn right into driveway.

Enter the lobby from either side of the building and proceed to the 3rd Floor and follow signs to NFG.

#### From Eastern NJ via Route 22 Westbound

Take Route 22 West. After passing the intersection of Route 202/206 North/South, proceed 1.7 miles toward *Clinton*.

Note: You will pass Ethicon (Somerset Corporate Center) and MetLife on your right.

Take U-Turn @ traffic light immediately after MetLife in order to proceed East on US 22.

Immediately through the traffic light you will pass Cordis, Alpharma & St Bernard Roman Catholic Church. The next driveway after St Bernard's Church is the Federal Credit Union (purple & white sign) and the 520 Entrance, turn right into driveway.

Enter the lobby from either side of the building and proceed to the 3rd Floor and follow signs to NFG.
